b. CY25 Strategic Planning

- The process for curating the CY25 SCTA Statewide Strategic Plan will follow the same format as last year.
 - In September, the focus will be gathering SCTA partner telehealth deliverables and goals for CY25.
 - October will be spent discussing these plans with the SCTA team and combining efforts to draft a cohesive plan that encompasses the goals of each SCTA partner.
 - The drafted plan will be presented to the Advisory Council during the November 2024 meeting prior to finalizing the plan in December.
- Looking ahead to CY26, the SCTA team plans to dedicate time during CY25 to reevaluate the strategic plan format to better capture the evolving telehealth landscape in SC.

5. Legislative and Advocacy Efforts

- a. Federal Updates Physician Fee Schedule
 - The Centers for Medicare and Medicaid Services released the <u>Physician Fee Schedule for</u> <u>CY25</u> in July and comment submissions are open until early September.
 - The schedule remains telehealth friendly, however, legislative action is needed to extend a number of CMS flexibilities.
- b. Medicare Flexibilities
 - There are several active proposed legislations that aim to extend or make permanent the Medicare telehealth flexibilities which are slated to end on December 31, 2024.
 - To showcase our eagerness for extensions, the SCTA is organizing a letter of support to submit to Congress with supporting signatures from various stakeholders across SC. The goal is to submit the letter during Telehealth Awareness Week in September to align with other supporting efforts. Please be on the lookout for a formal request asking for your organization to sign on in support.
