


Improving the health of all South Carolinians through telehealth.


- Vision:**

Value Proposition:
Telehealth in South Carolina will deliver high value through productive collaboration.

Strategies:

- **Service Extension:** All citizens of South Carolina will have equitable access to ambulatory care. Telehealth modalities will be used in the ambulatory setting to extend the reach of services that would otherwise be limited by travel and related barriers to care.
- **Hospital Support:** Every community hospital in our state will have access to telehealth partnerships that enhance its services and its finances. These Hospital Services represent partnerships that extend care between hospitals using telehealth with a focus on connecting resources from larger urban hospitals to community hospitals throughout the state.
- **Convenient Care:** All citizens in South Carolina will have affordable and immediately available patient-initiated virtual urgent and other health system-entry level care from an in-state provider. Convenient Care services are designed to engage individual patients through their own available devices in order to optimize utilization and maximize healthcare engagement.
- **Primary Care Support:** All primary care clinics in the state, with emphasis on Health Professional Shortage Areas (HPSAs), will have access to integrated services through telehealth partnerships. These services are intended to support the mission of the primary care clinic as a medical home, emphasizing the importance of local healthcare infrastructure while mitigating gaps in access to supporting resources.
- **Health Equity:** Targeted, novel initiatives will close the gap in access to healthcare services for high-priority health disparities. Health Equity services will make progress toward achieving health equity across the state in identified areas of health disparity.




A Decade of Collaboration

This year's Annual Report marks a significant milestone—celebrating a decade of transformative collaboration in advancing telehealth across South Carolina. While telehealth was present in our state before the South Carolina Telehealth Alliance was founded, it was the generous investment from our state legislature that united like-minded groups to collaboratively build a resilient statewide telehealth infrastructure, ultimately forming the South Carolina Telehealth Alliance in 2014. Over the past 10 years, each partnership has played a unique role in bringing our vision to life, driving the expansion and advancement of telehealth statewide, with a strong focus on underserved and rural communities.

The nearly **700 telehealth articles** in peer-reviewed journals published by SC researchers, the enactment of **two pivotal telehealth laws** enacted in our state, and more than **8.43 million statewide telehealth interactions** over the decade stand as a testament to our collaborative commitment to improving the health and well-being of our state. As we reflect on our achievements, it is evident that the strength of these partnerships has been both a catalyst for success and a driving force behind innovation. With our shared dedication, we are confident that we will continue to advance telehealth in new and impactful ways, working toward making South Carolina one of the healthiest states in the nation.


Total Telehealth Interactions 2014 – 2024


Telehealth Service Connections





Hospital Support programs are essential to the success and sustainability of South Carolina's hospitals. By partnering with urban hospitals, rural community hospitals can offer local patients access to high-quality specialty care via telehealth. This statewide collaboration enables patients to receive care close to home, reducing barriers and expanding access to essential services.

SC Department of Mental Health (SCDMH) Emergency Department Telepsychiatry Program offers mental health care 17 hours a day, 365 days a year, serving 27 hospitals statewide. This program helps reduce wait times for psychiatric consultations, ensuring patients receive timely treatment and are discharged from the ER more efficiently.

South Carolina's Telectroke Network is one of the state's longest-standing telehealth programs, dating back to 2008!

EVERY SC stroke patient is <1 hour of seeking expert stroke care, compared to just 56% of patients in 2008 when the Telectroke program began.



The Medical University of South Carolina's (MUSC) Telectroke Program was chosen by the Centers for Disease Control and Prevention (CDC) for an external evaluation, revealing the program improves key stroke-care metrics like door-to-needle time.¹

SC's Statewide Tele-ICU Program was implemented in 2010, partnering with community hospitals to provide an extra level of expert care to intensive care patients via telehealth.

Convenient Care offers South Carolinians round-the-clock access to low-acuity virtual healthcare. This patient-initiated service allows patients to describe their health concerns and receive a diagnosis, along with recommended next steps like prescriptions, all within the same day. Conditions treated include cold and flu, women’s health, skin issues, mental health, and more. This service provides a simple, accessible solution to receive care, especially for those in underserved and rural areas with barriers to travel to seek in-person care.


McLeod Health, MUSC Health, Prisma Health, Roper St. Francis Healthcare, Self Regional Healthcare, and Spartanburg Regional Healthcare System offer virtual urgent care for their patients and communities.

MUSC Health began partnering with SC Department of Corrections in April of 2024, providing virtual urgent care services to inmates. This partnership allows inmates to receive high-quality, on-demand care, thus reducing the need for physical transfers for in-person assessments.


**South Carolina Virtual Urgent Care Visits by Year Since Inception

Primary Care Support

Primary Care Support services are designed to strengthen the mission of South Carolina's primary care clinics as medical homes, emphasizing the importance of local healthcare infrastructure while addressing gaps in access to essential resources. By connecting both distant and local providers across the state through a variety of programs, these services help optimize primary care delivery statewide.

Remote Patient Monitoring (RPM) programs in SC remain essential tools for managing chronic conditions like diabetes, heart disease, and hypertension. By leveraging advanced equipment and technology, providers can remotely track a patient's clinical status, whether at home

or in a clinical setting. If abnormal levels are detected, providers can promptly alert the patient or their primary care team to address the issue and ensure timely intervention.

MUSC's Collaboration of Care Model (CoCM), introduced in 2023, integrates a behavioral health care manager with a consulting psychiatrist to deliver virtual behavioral health services in partnership with the patient's primary care provider.

Project ECHO/Telementoring programs in South Carolina empower providers, particularly those in rural areas, to deliver specialty-informed care to their patients through the support and knowledge received from experts across the state during virtual sessions featuring user-driven, didactic content. Focus areas of the ECHO groups in our state include pregnancy wellness, opioid use disorder, community opioid response initiatives, and peer support specialists for substance use disorder.



Health equity is a core strategy aimed at achieving fairness in healthcare across the state, focusing on areas with significant health disparities. These services are designed to reach the most vulnerable populations, requiring the collaboration of multiple stakeholders to create meaningful, lasting change.

Overall School-Based Telehealth Visits in 2024

South Carolina's School-Based Telehealth Network provides care directly to students at school, eliminating the need for students and parents to travel offsite for in-person care, reducing disruption to their daily routines. Programs include physical health, behavioral health, and trauma-based care.

MUSC's Statewide School-Based Telehealth Behavioral Health Program delivers expert care to students for a range of behavioral health needs, including anxiety, depression, trauma, grief and loss, ADHD, and others.


Since 2022, MUSC's Mom's IMPACTT (Improving Access to Maternal Mental Health and Substance Use Disorder Care Through Telehealth) Program has addressed the critical need for accessible perinatal behavioral health care by utilizing telehealth to provide care to those who are pregnant, within 12 months postpartum, as well as tele-mentoring to any health care provider caring for these patients.

Training & Education

Through the SCTA Telehealth Education Workgroup and the collaborative efforts of the **SC Area Health Education Consortium (SC AHEC)**, **Palmetto Care Connections (PCC)**, and the **Medical University of SC (MUSC)**, telehealth training and education resources have matured significantly over the past decade. Initially, telehealth training focused on introducing foundational concepts to this emerging field. Today, as telehealth has become a widely accepted and integral part of care delivery, educational efforts have evolved to address more advanced and comprehensive aspects of practice.



SC AHEC continues to provide online telehealth education to health care professionals and students in the areas of telehealth foundations, telehealth implementation, telemental health, and others.



In 2024, MUSC developed a statewide education roadmap to guide and align telehealth training initiatives in the post-pandemic telehealth era. The roadmap contains clinical, administrative, and technology tracks, designed to provide a statewide foundation for telehealth education from foundational knowledge to advanced competencies.

Launched in 2021, PCC's Digital Inclusion Program aims to provide digital literacy training to South Carolina residents, ensuring they are fully prepared to access care through telehealth.

MUSC Center for Telehealth Educational Visits: Over 175 students, health care providers and administrators, policymakers, and other telehealth stakeholders from across the US visited MUSC's Center for Telehealth in 2024.

Research & Outcomes



Telehealth research plays a critical role in expanding access to healthcare, improving patient outcomes, and bridging the gap for underserved populations. South Carolina is a national leader in this field, with the **MUSC Center for Telehealth** standing as one of only two federally recognized **National Telehealth Centers of Excellence (COE)**, a designation originally awarded by the Health Resources & Services Administration (HRSA) in 2017.

In 2024, the COE's areas of focus included:

1. Rural Hospitals
2. Primary Care
3. Maternal Health
4. Population Health & Health Equity
5. Telehealth Research Methods

The **South Carolina Center for Rural and Primary Healthcare (SC CRPH)** has played a helpful role in evaluating the adoption and delivery of telehealth across the state, ensuring our rural and primary care communities have the resources and support necessary for effective telehealth utilization. Since partnering with the SCTA in 2021, some of their key telehealth initiatives have included:

- Assessing barriers and facilitators of successful telehealth adoption among small rural and primary healthcare practices in SC during the COVID-19 pandemic.
- Evaluating the use of telehealth at alternate healthcare access sites, such as community libraries, and creating a telehealth implementation guide unique to these sites.
- Assisting in the development of the “SC Provider Telehealth Perspective Survey” used to assess barriers to telehealth adoption among SC providers and analyzing its 320+ survey responses to generate actionable strategies for improvement.

Promotions & Awareness



SCETV's decade-long partnership has been instrumental in raising awareness and promoting telehealth programs across our state. Through

its promotion on SCTA social media, SCETV's YouTube channel, and SC Public Radio, these impactful stories reach a broad and engaged audience.

Sustainability

2024 was a pivotal decennial year for telehealth in our state, with the enactment of the **South Carolina Telehealth and Telemedicine Modernization Act (Act 120)** in March. The law built upon the strong foundation established over the past ten years, guided by SCTA leadership.



Payer Engagement: In May 2024, SCTA Partners gathered in Columbia for the Collaborative Care (CoCM) Forum. Five CoCM programs presented successes and challenges of Behavioral Health Collaborative Care, including the integral role that virtual care plays in the model. SC payers also attended the forum, and on October 1, 2024, SC Medicaid began covering behavioral health collaborative care codes.



Federal Flexibilities: During Telehealth Awareness Week, representatives from the SCTA held a virtual briefing for South Carolina delegation staff in Washington DC, emphasizing the importance of telehealth in SC and urging leaders in Congress to extend the Medicare flexibilities, which were eventually extended through March 31, 2025, through Continuing Resolution.

While 2024 was a successful year in telehealth policy and legislation, there is still work to be done at both the state and federal level to ensure long-term program sustainability and patient access.

 - Created statutory definition of ‘Telemedicine’ and laws governing the practice of telemedicine, including tele-prescribing.
- 2018** SC Nurse Practice Act Enacted
 - Solidified role of APRNs as telehealth providers.
- 2020** Temporary COVID-19 Pandemic Telehealth Flexibilities Introduced
 - Licensure, billing & reimbursement, and provider-type flexibilities.
- 2024** Telehealth and Telemedicine Modernization Act Enacted
 - Created statutory definition of ‘Telehealth’, inclusive of non-MD health care practitioners.
 - Modernized tele-prescribing language in SC to facilitate improved access to certain controlled substances while maintaining important safeguards.



