# 3. SCTA Statewide Strategy


#### a. 2022 finalized milestones

## b. Strategy mapping and next steps

- Service Extension "Specialty Utilization among Medicare Population in SC"
  - Previously presented at last quarter's Advisory Council meeting, MUSC's Center of Excellence drafted a heat map to show the amount of specialty care by zipcode in SC using a five percent sample of SC Medicare data. Surgical services, as well as mental health services, were removed from this sample.
  - The draft map below displays counties where specialty care access may be limited, and with more investigation can help SCTA partners strategically target where to deploy telehealth programs to increase access.

Specialty Utilization among Medicare Population in SC




Hospital Support – Inpatient Neuro "In County Service Indicator"

# Inpatient Neuro "In-County Service Indicator"


- 2 years of Medicare data documenting inpatient neuro admissions by patient county (demand) per capita
- County hospital admissions per capita (supply)
- County demand county supply = in-county service indicator



- Convenient Care Heat Map of 2020 MUSC VUC Visits per capita by Zip Code
  - The first graphic below zooms in on the Tri-County area, showcasing virtual urgent care (VUC) utilization per capita by zipcode (darker shade = higher utilization).
  - The second graphic compares Tri-County VUC utilization (left), to the Tri-County social vulnerability (right). This indicates that the more socially vulnerable areas are not necessarily utilizing VUC as much as the less socially vulnerable zip codes.



## c. CY2023 strategy planning – next steps

- The goal for the next Advisory Council meeting in August is to have maps prepared to share for the two remaining strategies – Primary Care Support & Healthy Equity.
- These maps are a "proof of concept", and along with the Primary Care Support and Health Equity maps, will serve as a guide for SCTA partners as they develop goals and milestones for CY2023 strategy planning.

## 4. Legislative and Advocacy Recap/Update

- a. Recap 2021-2022 efforts
  - Representative Herbkersmanintroduced SC House Bill 5161:
    - Introduced 3/29/22 did not make it out of committee (committee was adjourned)
    - Key components of the bill included:
      - o Defining key telehealth terms in statute
      - Removing originating site restrictions
      - o Removing outdated language prescribing practices via telehealth
    - Although this did not make it out of committee, it acted as leverage for conversation with payers to come to a long-term solution moving forward.
  - Senator Shealy introduced SC Senate Bill 1179:
    - "Allows for licensed social workers, professional counselors, marriage and family therapists, addiction counselors, and psycho-educational specialists to provide services using behavioral telehealth."
      - Signed by Governor on 5/13/22
    - i. A <u>Medicaid bulletin</u> was published on 4/29, outlining updates on telehealth flexibilities issues during the COVID-19 Public Health Emergency (PHE). Updates include:
      - 1. Flexibilities that are being made permanent
      - 2. Flexibilities that will be extended for further evaluation for one more year after the expirations of the current federal PHE
      - 3. Flexibilities that will expire at the end of the current federal PHE

# b. Focus for coming months

 The SCTA will continue its efforts to advance telehealth in SC, via conversations and engagement with SC payers through the summer and fall to inform legislative action next session.
